DISTINGUISHING FEATURES OF THE CLASS

This is a mid-level professional planning position responsible for coordinating and maintaining data used in planning projects.. The incumbent will integrate and analyze information from a variety of sources (e.g., assessment data, census results, soils information) to develop reports and products in support of planning programs. This position is the technical lead on Planning Department Geographic Information System (GIS) development and database management. This work is performed under the general direction of the Deputy Commissioner of Planning; it requires a high level of autonomy and independent judgement in executing assigned tasks and developing internal support programs. The position is central to and works at a high level with the entire staff to provide leadership in data analysis and best use, assist in data interpretation as it relates to planning, and as needed, to provide computer assistance to the staff. Does related work as required.

TYPICAL WORK ACTIVITIES

- Provides analytical leadership to support and develop environmental, comprehensive, economic, demographic, housing and transportation planning studies;
- Compiles data for distribution to the public, local agencies, and local governments;
- Works with municipal officials and government agencies to prepare reports and maps to assist in policy decisions;
- Designs, manages and maintains the Planning Department's computer databases and integrates other county databases as needed to assist Planning Department staff;
- Designs, manages, develops, and maintains the department's GIS, including creating interfaces for use by untrained
 personnel, assisting staff in using the system, and transferring information from other organizations, operating systems
 and formats;
- Develops interagency coordination and cooperation to ensure appropriate integration of the GIS with other County agencies;
- Responsible for computer-related administrative items, including purchasing, budgeting, and maintenance contracts.
